

Credit conditions: Clinical Pharmacology
Faculty of Medicine with the Division of Dentistry and Division of
Medical Education in English MUB

Field of study: Medicine in the academic year 2024/2025
for students of the fourth year.

Completion of obligatory classes (classes, lectures).

1. The course "Clinical Pharmacology" takes place within the hours envisaged by the study program and according to the classes program presented in detail in the first lecture, published on the website of the Clinical Pharmacology Department.
2. Students are required to attend all lectures and classes.
3. Classes:
 - 3.1. During classes, no meals, drinks and mobile phones are allowed.
 - 3.2. Students are required to prepare for classes and participate actively in classes.
 - 3.3. At each classes students are assessed with the scope of the existing material on the basis of oral answers.
 - 3.4. Students who are absent justified (medical leave, deanery leave) are obliged to provide an attestation for the assistant at the latest in the next class.
 - 3.5. Absence on exercises from a given day should be done in the following training week after a period of absence and prior approval of the assisting assistant.
 - 3.6. Students who have not received a credit for the classes may take a written delay in the deadline given on the website of the Department.
 - 3.7. Students who have an absence unjustified in the classes, cannot proceed to pass the current material.
 - 3.8. The student is obliged to pass all the classes.
 - 3.9. Students who do not complete all the classes, after completing the block from Clinical Pharmacology are required to pass all material within the prescribed period published on the website of the Department in the Didactics tab.
4. Lectures:
 - 4.1. It is not allowed to take pictures and record lecture contents (copyright).
 - 4.2. A student absents from the lecture due to absence is justified and obliged to pass the lecture material after the end of the cycle within the deadline given on the website of the Department in the Didactics tab.
 - 4.3. A student absent from the lecture because of unexcused absences may not proceed to pass the lecture material.
5. Credit conditions of the Course of Clinical Pharmacology:
 - 5.1. Student who does not fulfil the conditions: pass all classes and lectures, is obliged to pass the obligatory material after completing the block of Clinical Pharmacology within the deadline published on the website of the Department in the Didactics tab.
 - 5.2. Students who are 50% or more of absence from obligatory classes do not receive credit for the Course.
 - 5.3. Absence on the final pass within the time limit without excuse results in failure of the Course. Justification should be submitted no later than within 14 days of the credit date.
 - 5.4. Final test (20 single choice questions, 1 point for each question) include students who get a minimum of 60% (12 points / 20 points).
6. The student has the right to inspect his/her written work no later than 7 days after publication of the results.
7. The study regulations prohibit not only the use but also the possession of any electronic devices during exams and tests. All instances of having electronic devices on one's person (even if turned off) or bringing active devices into the examination room will be treated as unauthorized assistance.
8. In the event that a student is found to be using unauthorized sources during an assessment, the consequences are as follows, in accordance with the Study Regulations §10 and §15 items 11 and 12, as well as the Regulation of the Ministry of Science and Higher Education on the detailed procedure for explanatory and disciplinary proceedings in student matters:
 - 8.1. Immediate termination of the student's exam/test/assessment with a failing grade.
 - 8.2. Notification of the Rector about the use of unauthorized assistance, in order to initiate disciplinary proceedings against the student.
 - 8.3. If the incident occurred during an exam, the student loses the right to participate in retake exams and the commission exam.
