







## **Contest Rules:**

- 1) Organizer of this photography contest is the Medical University of Bialystok, ul. Kilińskiego 1, 15-089 Białystok. It is conducted by the International Cooperation Office of the Medical University of Bialystok with headquarters in the right wing of the Branicki Palace, ul. Kilińskiego 1, 15-089 Białystok.
- 2) Objectives of the contest: a) creating a photography database showing the attractiveness of our region, to be published, among others, in the myMUB mobile application; b) awakening interest in the region; c) showing the region's beauty to foreigners.
- 3) The contest is directed to the inhabitants of the Podlasie Voivodeship and also to the entire academic community of the Medical University of Bialystok.
- 4) The photograph(s) should present the places mentioned in the contest description. It is allowed to send one or several photographs (maximum 5).
- 5) Photographs should be taken in good resolution, i.e. min. 1920x1080 pixels.
- **6**) Photomontage consisting of combining elements of several pieces into one is not allowed.
- 7) The file containing the photograph(s) should be named as follows: NAME\_SURNAME\_WORK\_TITLE.JPG.
- 8) Photographs should be sent by 01.09.2020 before 15:30 directly to the e-mail address international@umb.edu.pl.
- 9) The photographs will be evaluated by a commission consisting of prof. dr hab. Tomasz Hryszko - Rector's Plenipotentiary for International Cooperation and employees of the International Cooperation Office, the best three works will be awarded. The Commission may refrain from awarding the works or award fewer prizes than intended.
- 10) Winners will be notified about the place they have taken and how the prize can be collected by e-mail, to the same e-mail address from which the photographs were sent. The list of winners will also be published on the website and Facebook of the Medical University of Bialystok.
- 11) The organizer of the contest reserves the right to publish personal data (name, surname, title of work) of persons participating in the contest.
- **12**) Main prizes can be collected from the day the results are announced on the website and Facebook of the Medical University of Bialystok until 30.10.2020 in the International Cooperation Office, in room 207 (Welcome Centre). After this date, they will become the Organizer's property.
- **13**) It is not allowed to place watermarks/information about the author directly on the photograph. The International Cooperation Office will mark the authors of the photographs in a uniform way.
- 14) By submitting photographs, the contest participant declares that he/she:











- a) is the author of the attached photographs, and the attached photographs meet the requirements of the contest rules;
- b)has exclusive and unlimited copyright to the photographs;
- c) agrees to the publication of photographs sent as part of activities performed in the scope of the "Welcome to Poland" program of the Polish National Agency for Academic Exchange;
- **d**)agrees to the free of charge publication of photographs in the gallery on the website of the Medical University of Bialystok;
- e) does not claim proprietary copyrights to the sent photographs;
- **f**) became acquainted with the information on the processing of the contest participant's personal data (located below).
- **15**) Participants who do not meet any of the requirements contained in the contest rules, or provide false information about the submitted work, will be automatically disqualified.
- **16**) The organizer does not claim the transfer of copyrights or property rights to the sent photographs, they remain the intellectual property of the authors.
- 17) The Contest Rules enter into force on the day of their announcement.
- **18**) The activity is financed under the project "Internationalization 2.0. New quality in building the culture of internationalization of the Medical University of Bialystok", co-financed from the European Social Fund under the Operational Program Knowledge Education Development.
